All Vendors must be paid One (1) week ahead, this is how your spot will be held from week to week. Your first weekend payment must be made along with this Application, this payment is non-refundable. This means that with this application you must include the following payments: Application fee \$15.00, Membership fee \$35.00, and for each booth \$25.00.

All Vendors who commit to participate a min of 15 weeks will be listed on our Website, updates will begin as applications and payments come in. Application and payment deadline is May 1, please have all applications and payments to us by May 1, 2015, we cannot hold your spot if this Application and payment are not made. Vendors may choose to pay weekly at the Market for your next upcoming day or you can speak to the Market Manager for additional payment options.
